- (vi) To make plan and formulation of development projects independently or inassociation with other agency.
- (vii) To monitor the progress projectes of school and to report on its developement projects or projects of its other agencies on their request.
- (viii) To work for the welfare of economically weak students and their other problems relating to their education.
- (ix) To foster and encourage education in particular and other in general.
- (x) To grant, pay or give rewards to students with a view to help them in prosecuting their students.
- (xi) To publish books, pamphlets towards, periodicals, magzine and other educational pamphlets in India or aboard for the spread and advancement of education.
- (xii) To give, provide and render help and assistance for the upliftment of the poor boys.
- (xiii) To receive and collect any gift, subcriptions and donation either in cash or in kind or acquire by any other lawful ways and means and spend the same in fulfilment of all or any of the ends and object of the trust.
- (xiv) To acquire by purchase, take on lease, hire or by gift as otherwise and hold any movable and immovable property or properties as any right or privillage that may be deemed necessary and useful for the advancement and betterment of the objects of the institutions.



(xv) To construct, renovate or repair the building of the

(xvi) To teach the know, how and give vocational and other training to the poor and deserving students like, Computers, Typewriting, carpentary, Sewing, cutting, knitting, weaving and other works.

(xvii) To develope and spread language and culture in students of the school.

(xviii) To take over, observe amalgamate with any other trust or association or institution whose objects are similar to the objects of this trust.

#### D MEMBER SHIP:

No person shall be eligible to be a trustee if he is

#### E <u>CESSATION OF THE MEMBER SHIP</u>

A person shall seize to be a trustee in any of the following rea-

- If he/ she becomes bankrupt or (2)
- If he/she becomes incapable to act or (3)
- If he/she resigns from his office (4)
- If he/she is convicted of any criminal offence involving (5)moral turpitude.

#### LEGAL PERSONALITHES F

The board of trustee shall be entitled to sue in the name of the trust and may similarly be sued in the name of the trust.

#### **CESSATION OF TRUSTSHIP** G

The board may by an unanimous vote of all the trustees for the time being purposed to be removed, remove any trustee permanent or other wise from the office after finding the trustee to be guilty of serious missconduct in relation to or concerning the trust estate or trust officers and after arising at a definite conclusion that for the reasons to be recorded in writing the continuous of the trustee purpose to be remove as trustee or these presence was desirable keeping to the object of the trust in view and other related or connected matters, provided, however no conclusion of the such guilt shall be arrived at, without giving notice to hear trustee purposed to be removed a full and for opportunity of replacing his conduct or the charges level against him for his removal and the decision of the board of trustee in this behalf shall be final and binding and shall not be called in question any where.

#### APPEAL AND READMISSION OF MEMBER H

If any terminated trustee wishing to appeal for readmission, he shall be allowed to make appeal to the Board of Trustees with full facts and

figures justifying validity of his membership. After satisfactory appeal, Board of trustees may readmit the trustee concerned or may turn down the appeal.

## POWERS OF BOARD OF TRUSTEES

- 1. The Board of trustees shall appoint the members of MANAGING COMMITTEE that shall assist in day- to-day functioning of the trust. The Board of trustees shall determine the member of the members of managing Committee. The Annual meeting of the managing Committee shall be held once in a year and special meeting as and when required with the approval of the chairman trustee. The Budget and all afairs of the Trust have to be passed in the Annual Meeting of the Managing Committee. The tenure of the members of Managing Committee shall be for five years.
  - 2. The Board would fill in any vacancy caused by death, resignation or by any other reason of any Trustee by majority decision of the Board of Trustees.
  - do all such acts as may be considered necessary for the benefits of the Trust and / or acquisition, disposal, sale of all kinds of properties, furniture, appliances etc. and affairs. For this purposes for day to day working of the Trust subject to the conditions that the Board of trustees determine. The Board of Trusties shall solely utilies and apply all earning, movable or immovable properties towards the promotion of its aims and objects only as set forth and no profit on there, shall be paid or transferred, in any manner whatsever be to present or past.

- particulars of all the business to be transacted, shall be delivered or sent by post to the trustee of the Board at his last known address at least ten days before the meeting, but the proceeding of any meeting shall not invalid by reason of any business being considered there inspite of the non-inclusion thereof in the general or particulars of the original notice of such meeting.
- (ii) The Chairman Trustee, on the request of 1/3rd trustees, can call a special meeting at such time, date & place as the Chairman determines.
- (iii) Resolution passed without any meeting of the trustees but by circulation there of and evidence written under the hands of two thirds of the trustees shall be as valid and effectual as a resolution duly passed at a meeting of Trustees.
- (iv) Three Trustees shall form a quorum for a meeting of the Board.

#### T <u>DISSOLUTION OF TRUST</u>
