(x) To grant, pay or give rewards to students with a view to help them in prosecuting their students.

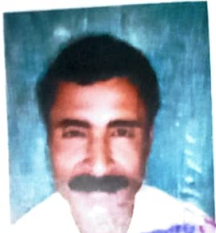
(xi) To publish books, pamphlets towards, periodicals, magazine and other educational pamphlets in India or abroad for the spread and advancement of education.

(xv) To construct, renovate or repair the building of the School.

(xvi) To teach the know, how and give vocational and other training to the poor and deserving students like, Computers, Typewriting, carpentry, Sewing, cutting, knitting, weaving and other works.

(xvii) To develop and spread language and culture in students of the school.

(xviii) To take over, observe amalgamate with any other trust or association or institution whose objects are similar to the objects of this trust.

(xix) Without prejudice to the generality of the above objects and for effectively carrying out the same, the trust shall have power to receive, hold and possess any property including securities of any kind and to contract and maintain any building to manage, transfer or otherwise dispose of or deal in any property of security and to enter into any contract in which the trust may be interested.

D MEMBERSHIP:

No person shall be eligible to be a trustee if he is

- (1) An undischarged insolvent or insane or
- (2) ~~Convicted of any offence involving moral turpitude or~~
- (3) A minor.

CESSATION OF THE MEMBER SHIP

A person shall cease to be a trustee in any of the following reasons.

- (1) If he/she dies or

- (2) If he/ she becomes bankrupt or
- (3) If he/she becomes incapable to act or
- (4) If he/she resigns from his office.
- (5) If he/she is convicted of any criminal offence involving

moral turpitude.

F LEGAL PERSONALITIES

The board of trustee shall be entitled to sue in the name of the trust and may similarly be sued in the name of the trust.

G CESSATION OF TRUSTSHIP

The board may by an unanimous vote of all the trustees for the time being purposed to be removed, remove any trustee permanent or other wise from the office after finding the trustee to be guilty of serious misconduct in relation to or concerning the trust estate or trust officers and after arising at a definite conclusion that for the reasons to be recorded in writing the continuous of the trustee purpose to be remove as trustee or these presence was desirable keeping to the object of the trust in view and other related or connected matters, provided, however no conclusion of the such guilt shall be arrived at, without giving notice to hear trustee purposed to be removed a full and for opportunity of replacing his conduct or the charges level against him for his removal and the decision of the board of trustee in this behalf shall be final and binding and shall not be called in question any where.

The Meeting of the Board of trustees shall be held ones in a year preferably on the second Day of financial year suitable date as determined by the chairman Trustee.
